More “in-depth” healing sessions (consisting of as examples but not limited to: Shamanic soul retrieval, deeper energy healing work, business or home clearings & blessings to name a few) can range up to as high as but not limited to \$2000+ per session(s), being that the length and monetary sacrifice for the healing session will vary per individual situation (depending on the situation, an available sliding scale fee may be determined at the time of the “in-depth” session). FaLiThi Shamanic Healing Live Readings phone line sessions will be charged at a rate per minute or at a flat fee per 30 to 60 minutes increments different from regular scheduled sessions as stated above. Current and expo/fair specials will be charged at a special rate or flat fee. All sessions provided by FaLiThi Spiritual & Energy Healing are to be paid before the session begins by cash, PayPal, or credit card through PayPal. No insurance is accepted.
- ◆ The theoretical approach to a session is to intuitively assist the client with information and suggestions for further assistance as appropriate within the community of alternative holistic practitioners.
- ◆ The client has a right to reasonable notice of changes in services or charges. (As they are responsible to find out on their own on our website from time to time.)
- ◆ The client has a right to current information concerning the practitioner's assessment and recommended service that is to be provided, including the expected duration of the service to be provided.
- ◆ The client may expect courteous treatment and to be free from verbal, physical, or sexual abuse by the practitioner.
- ◆ Client records and transactions with the practitioner are confidential, unless release of these records is authorized in writing by the client, or otherwise provided by law.

- ◆ The client has a right to coordinated transfer when there will be a change in the provider of services.
- ◆ The client may refuse services or treatment, unless otherwise provided by law.
- ◆ The client may assert the client's rights without retaliation.

I understand that I can direct my complaints regarding complementary and alternative health care practitioners to the office of health care consumer assistance, advocacy, and information at the Minnesota department of health.

I understand that

- (1) the practitioner is not credentialed in the state of Minnesota to practice medicine, chiropractic, osteopathy, nursing, physical therapy, dietetics or nutrition practice, or acupuncture practice.
- (2) the practitioner may provide me with personal consultations, screenings, assessments, an explanation of the practitioner's method of detection and assessment of my health problems and concerns, educational services, and recommendations regarding the complementary and alternative health care practice to be used; and
- (3) these actions do not constitute a diagnosis from a licensed physician chiropractor, or acupuncture practitioner. I understand that if I desire a diagnosis from a licensed physician, chiropractor, or acupuncture practitioner, or services from a physician, chiropractor, nurse, osteopath, physical therapist, dietitian, nutritionist, acupuncture practitioner, or any other type of health care provider, I may seek such services at any time.

I understand that my health care records and communications and transactions with the practitioner shall be kept confidential, unless I authorize the release of records in writing or as otherwise provided by law.
